- 6 hours of Behind the wheel drives are scheduled **outside** of classroom time and continue for two weeks **after** classroom instruction ends.
- Students cannot miss more than 3 days of class (student must be present for 1st day of class) . All missed classes and drives will have to be made up during the following class session, usually within the next 5 weeks. Be sure the classes and behind-the-wheel drives fit into your schedule! Sports and other afterschool activities, do not take precedence over what is required in this class!
- The first hour of the first class is a parent / student orientation— parent or legal guardian must attend class for this hour. This includes any ZOOM class.
